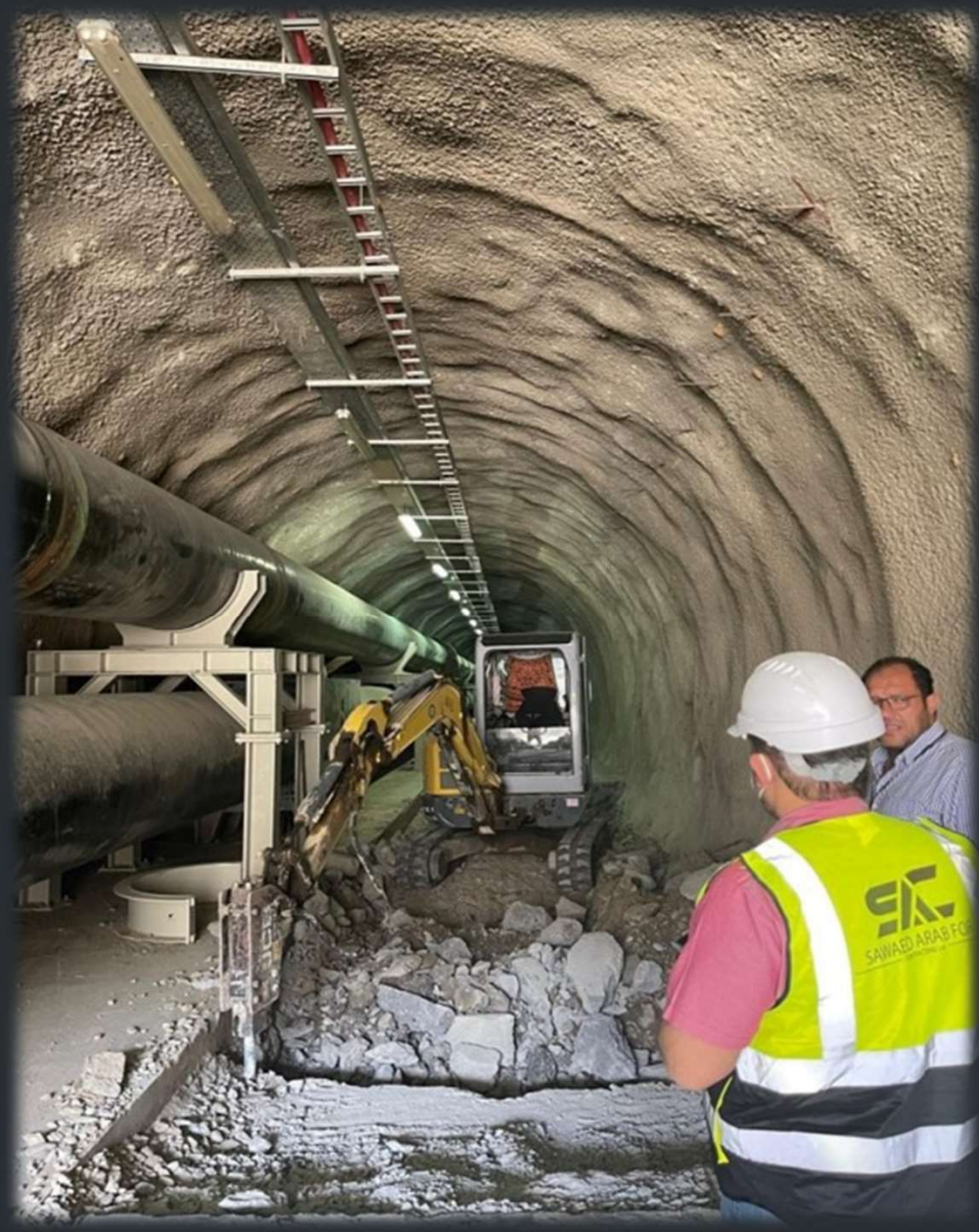

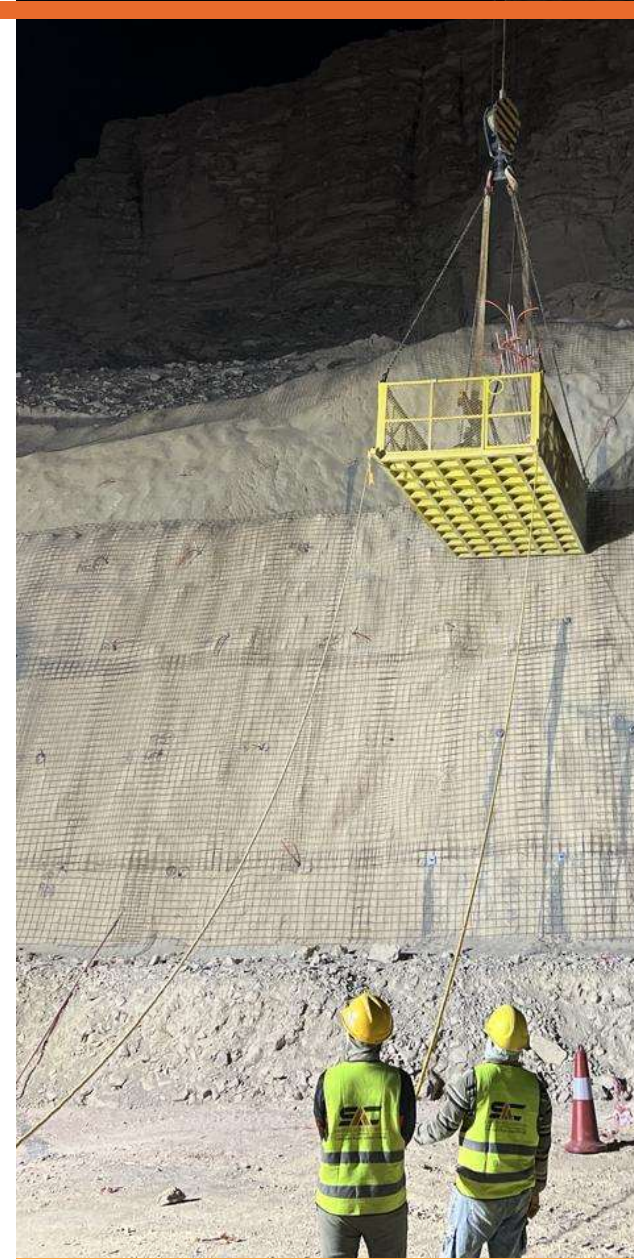

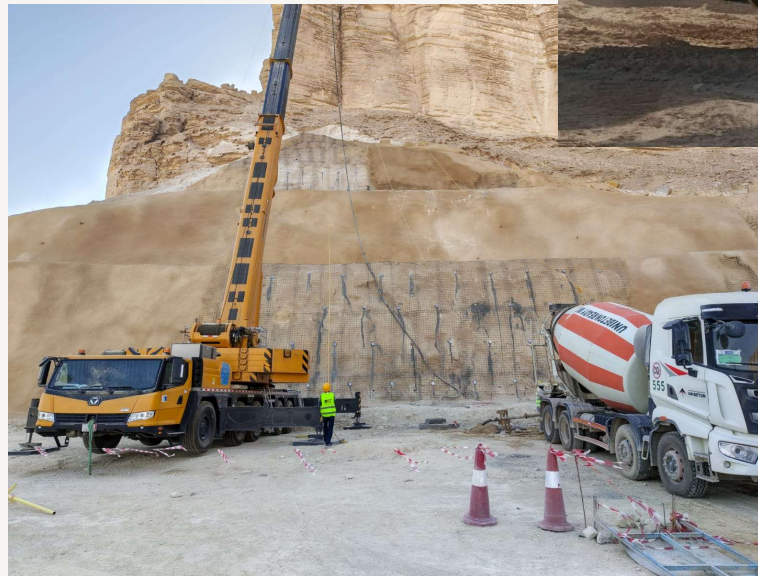

RIPRAP

Durable, interlocking rock protects slopes, valleys, embankments and bridge approaches from erosion and hydraulic scour.

Stone size and layer thickness follow hydraulic and geotechnical requirements.
